1. JCSL

The Jackson County Soccer League (JCSL) is a non-profit, public, education soccer organization with the purpose of advancing the cause of soccer within its area of jurisdiction. JCSL is affiliated with the West Virginia Youth Soccer Association and the United States Youth Soccer Association. JCSL will sponsor under the guidelines of the WVSA all three types of teams (recreation, recreation all star, and travel teams) as defined in the WVSA Rules and Regulations under definitions. Per WVSA requirement, JCSL will deny position to be held by a Board member, coach, volunteer, etc which has been arrested and convicted for child abuse, physical abuse, domestic violence, sexual abuse, or any felony or other crime which is detrimental to soccer players, in accordance with WV Law, USYSA, USASA, and US Soccer bylaws, policies and procedures. If JCSL dissolves, all monies and its properties goes to WVSA.

## 2. RECREATIONAL LEAGUE PHILOSOPHY

The primary goal of the recreational soccer program of JCSL is for the players to have fun within a learning/teaching environment. The recreational program is not about winning, it is about teaching, so that children have fun, learn to love the game of soccer, and to become as skilled a soccer player as possible.

The most enjoyable aspect of soccer for the players is kicking the ball. Small-sided games are used for $\mathrm{U}-6, \mathrm{U}-8, \mathrm{U}-10$, and $\mathrm{U}-12$ to provide each player more opportunities for contact with the ball.

## 3. GENERAL GUIDELINES

1 Teams may only participate in games approved by the JCSL Board Members.
2 Only properly registered players in good standing with the JCSL (i.e. not suspended) are allowed to participate in league games. The person(s) responsible for allowing the ineligible player to participate shall be referred to the JCSL Disciplinary Board.
3 Regularly scheduled JCSL games are mandatory. A coach cannot withdraw the team he represents from any scheduled competition as a means of protest. Non-appearance for regularly scheduled JCSL games without prior agreement with the opposing teams' coach will result in reference of the offender to the JCSL Disciplinary Board, unless a valid reason for the non-appearance is supplied to the club vice president. The vice president is the final authority on the decision to reschedule the game.

4 In inclement weather, games shall be played as scheduled and only the referee in charge or the club president of the hosting site will have the authority to cancel such games. 5 If a player misses three sessions in a row or five sessions in any ten session period, the player may be subject to removal from the JCSL program. Removal of a player can only be done with the approval of the club president and JCSL registrar. A session is defined as a scheduled practice or a scheduled game for which the player had adequate notification. 6 If a player shows up for games and not for scheduled practices, then that player is played at the discretion of the coach for the following game only.
7 Any injury to or damage caused by a JCSL participant must be reported to the club president who is in charge of the insurance and safety program.
8 No one except participating players will be permitted to stand with in 5 feet of the touchline or within 5 yards of the goal line during the play of a game.
9 Refunds - there will be no refunds given.

## 4. SPORTSMANSHIP

10 At the conclusion of each game, the participating teams will line up along the team's sideline and exchange gestures of good sportsmanship. This activity will be observed by the game officials. Failure of the players or coaches to participate in this display of good sportsmanship will receive a "red card" resulting in their suspension from the following game. 11 It is the duty of each player, coach, parent, and other persons in attendance at JCSL activities to conduct themselves in a civil manner. Anyone who exhibits behavioral tendencies which are detrimental to the enjoyment of the game for others is subject to removal from the
game or suspension from the JCSL. Specific problems are to be referred to the JCSL Disciplinary Board.
12 Any person displaying gross unsportsmanlike conduct resulting in an ejection (red card or two yellow cards in one game) must serve a suspension for the following regularly scheduled JCSL game. The ejected person may be brought before the JCSL Disciplinary Board for the consideration of extended or permanent suspension by recommendation of either the presiding referee, either coach, or the president of the club. The club president shall hold the player pass card of the offender and it is the coach's responsibility to retrieve the pass card following the suspension.

## 5. AGE GROUPINGS

The playing season for JCSL recreational soccer extends from January 1 to December 31 of same year. The appropriate age group for any player is determined on January 1 of the year and remains the same for the entire 12-month playing season. All players must be a minimum of 4 years of age on January 1 to register for JCSL league play anytime during the playing season. No child will be allowed to play up an age group unless request is made by parent and approved by President.

[^0]In case a team is short of players but is within the guidelines, the opposing team may reduce its number of players on the field to an equal number, but still needs to meet the minimum $50 \%$ playing time for each player.
Or, the coaches of the opposing teams may agree to have the under-manned team "borrow" players from the other team to enable the maximum number of players to play. This can occur only if the coaches agree prior to the start of the game. In the event of an ejection during the course of the game, the opponent does not have to reduce in kind by the number of players ejected..

## 7. TEAM FORMATION GUIDELINES

13 JCSL is a recreational league only. The goal of the team formation process is to form recreational soccer teams that are equally competitive within the club. Objective is to try to get an even spread of talent, of ages and boy/girl ratio for teams U8 through U12.
14 Players will be placed on teams by Registrar and one other officer.
15 All teams must have no more than 2 coaches, with their children being on their team.
16 Coach and assistant coach pairing will be determined by the board.
17 "Guest" players are not permitted. Only rostered players on the two teams scheduled to play a given game may participate in the game. However, borrowing of players from one team by the other is permitted, as described in Section 6. Exceptions for Guest players under Section 19, Tournament play.
18 The only Guaranteed requests are the placement of brothers, sister, relatives, or foster children living in the same household. Any other requests may be honored if board feels there is a need for that.
19 Player registering for club play after the draft process has been completed will be assigned to the teams by the registrar and president, if space is available.
8. TRAVEL

20 Jackson County Soccer League is a recreational league but does accept travel players.
21 Travel players will be divided up among the teams in their age brackets.
a. Any rec player, playing travel at anytime during the season (fall, winter, spring), can be moved to another team in the following season, to keep teams even.
b. Any child playing travel is welcome to play in the JCSL. Players and parents are held to the same accountability as rec players and parents. Games will not be canceled due to travel players not being present for games.

## 9. FACILITIES AND EQUIPMENT

a. Fields - The field sizes will conform to small sided game rules for U-6 through U-12 age groups.
Fields for U15-U19 and above will conform to FIFA.

c. Player Equipment

22 All players on the field of play must wear shin guards during all practice sessions and games.
23 Watches, rings, earrings, other jewelry, or anything the referee deems unacceptable or dangerous to any players will not be worn during JCSL practices or games. NO EXCEPTIONS!

24 Each player will be properly dressed while on the field of play. Proper dress includes wearing team shirt with the team colors, shin guards, socks covering the shin guards, safe shoes, shorts, and any other requirements stipulated by the referee. No team shall add anything to the team shirts. ALL that is permitted is the number for U8 and up and the sponsor logo.
25 In inclement weather, players may wear additional clothing, provided it is worn under the issued uniform.
26 Players fitted with any type of cast, air cast, or splint may not participate in club games or Practices for U15 and down. In U19, casts may be worn, but must be wrapped in padding and taped for protection.
27 Eyeglasses should have an elastic headband. (Referee has the right to require.)

## 10. PRACTICES

A practice is any session involving soccer drills or strategy which includes a parent or coach and more than 3 members of a single team.
Practice times permitted per team:

28 Practices sessions (especially for the younger players) should focus on doing, moving, and having fun. Younger players do not like to stand in lines and have short attention spans. Practice time should be planned accordingly. Times listed are the most time to be practiced For each bracket. Less time practiced is permitted.

## 11. GAME DURATIONS

29 All teams should arrive at the playing field a minimum of 15 minutes prior to the schedule game time.
30 All games during the regular season resulting in a tie at the end of regulation, will remain a tie.
12. PLAYING TIME

All players in attendance at the start of regular season games or club tournament games must play in at least half of the game ( $50 \%$ ). A player arriving after the start of the game may be
played at the discretion of the coach. Exceptions may be granted for illness, injury, and disciplinary reasons. It is the coach's responsibility to ensure
all players play the required amounts in each game. Coaches failing to provide required playing time for allplayers on their team will be referred to the JCSL Disciplinary Board.
Players may not be guaranteed $50 \%$ playing time if they continually miss practices and games, but only after approved by JCSL Disciplinary Board.
For additional restrictions and guidelines on playing time refer to Section 3, General Guidelines.

## 13. SUBSTITUTIONS

U6 Free substitutions
U8 \& Up - Substitution will be allowed in accordance with USYSA Rules, but only with the referee's permission, during specified breaks in the game play. Coaches must have players prepared to enter the playing field before the game break occurs, with player standing at sideline at field center line.

## 14. SPECIAL U-6 \& U-8 PLAYING RULES

31 In U-6 games - Coaches, assistant coaches, or parents act as referees. One coach from each team is allowed on the playing field for the entire game. No one can pick up the ball in the field of play, (no goalkeeper). There are no throw-ins. Balls kicked out of play on a touchline will be returned to play with a kick-in. Balls kicked out of play on the goal line will be returned to play with a goal kick or corner kick.

32 In U-8 games - Coaches, assistant coaches, or parents can act as referees, if needed. Each team can provide a referee for half of the game. No one can pick up the ball in the field of play, (no goalkeeper). Balls kicked out of play on the goal line will be returned to play with a goal kick or corner kick.
33. U-8 throw-ins, players will be given two attempts to properly throw the ball into play before the ball is given to the opponent.

34 Goal Kicks may be taken from a point inside the goal area.
35 All fouls will result in an indirect free kick with all the opponents three yards away from the ball.
36 All free kicks are indirect. A goal cannot be scored directly from a free kick, or from a kickoff. This means that the ball must touch at least one other player before it enters the goal to be counted as a score.
37 There are no penalty kicks. No free kicks can be taken from within the opponent's goal box.
38 No offside rules are observed.
39 No score shall be kept.

## 15. SPECIAL U-10 PLAYING RULES

40 If league referees are available they will call the game, otherwise a coach, assistant coach, or parent will act as the referee. Only the individual acting as the referee is allowed on the playing field during the game. The acting referee may be exchanged between teams during the half-time if desired by the coaches.
41 Opponents shall be 8 yards away from all free kicks.

42 Penalty kicks are used.
43 Field will have a build out line.
a. It is used to promote playing the ball out of the back in an
unpressured setting. When the goalkeeper has the ball, either during play or from a goal kick, the opposing team should move behind the build out line. Once the opposing team is behind the build out line, the goalkeeper can pass or roll/throw the ball to a teammate (no punting). After the ball is put into play by the goalkeeper, the opposing team can cross the build out line and play resumes as normal.
b. An attacker is not considered in an offside position unless s/he is nearer to the opponent's goal line than the second last opponent AND the ball AND the build out line.

## 16. COACHES

44 The coach shall be responsible for their own conduct as well as that of all other coaches, players and parents associated with their team while a game is in progress. It shall be the coach's responsibility to see that the offending parents leave and report to the JCSL Disciplinary Board.
If a coach is ejected (red card) from a game for either his or a spectator's behavior, they shall be required to report to the JCSL Disciplinary Board for a full review and action.
45 Any issues not taken under control, will result in the game being called. Referee will blow final Whistle and game will be over with no score or win.
46 Coaches shall ensure that their team has the highest regard for good sportsmanship and respect for game officials.
47 Coaches or other persons shall not enter the field of play unless requested by the referee. (See special rules section for U-6 guidelines, exception)
48 Coaching during games shall be limited to the sideline area only. No coaching will be allowed from behind or around the goal area. (See special rules section for U-6 guidelines, exception). 49 It is mandatory that a representative from each team attend the coaches' pre-season meeting.
a. ALL coaches and assistant coaches MUST take the coaching class to prepare them with the rules for the game. This is mandatory for all coaches that are not certified referees. They also must take the Safesport, Concussion Course and Risk Management before they receive their roster and can practice.
50 Coaches will ensure that field is safe prior to each practice and game. Ensuring goals are secure and field free of holes and other unsafe conditions.

51 The coach of the team designated as home must make sure that the field is marked and corner flags properly installed. U6 does not use flags.

52 Coaches will allow only JCSL member registered with WVSA to play and practice with his/her team.

53 Each Head Coach must have an assistant coach so that practices and games will proceed as scheduled.

## 17. REFEREES

54 The JCSL referee has an awesome task and responsibility. Once they are given authority,
they must be supported by all JCSL officials, coaches, players, and parents. ANY ABUSE OF REFEREES WILL NOT BE TOLERATED. (Please see Zero Tolerance below) 55 JCSL referees will enforce the rules of competition defined by JCSL, WVSA, USYSA, and FIFA (USSF). Where JCSL and WVSA rules are not specified, the laws of FIFA (USSF) prevail.
56 JCSL referees will always place primary emphasis on the welfare of players. The game will be officiated in a manner conducive to clean competition and good sportsmanship.
57 Referees shall not be faulted for judgmental decisions and opinions rendered in good faith during the course of officiating a game. Coaches should address complaints of overall referee performance ( and a specific call) to the JCSL Referee Coordinator.
58 Referees are encouraged to give pre-game instruction to both players and coaches concerning any special conditions that may have an impact on the game.
59 Referees are encouraged to verbally communicate to players and/or coaches their decisions made during the course of a game. Referees must never coach, while officiating a game.
60 All referees must be certified by JCSL. In the event of a shortage of certified referees, linesman may be selected from spectators or advanced players.
61 If an ejection (red card or second yellow card) of a player, coach, or spectator occurs, the referee shall request that the offending party leave the immediate area of the game and have no further contact or communication with the remaining players/coaches. If they refuse, the referee may terminate the game. In the event a game is terminated, the referee shall report in full, in writing, within 48 hours, the circumstances, the score up to that time, and any relevant details to the club president and JCSL Disciplinary Board. The JCSL Disciplinary Board will decide the outcome of the game as to replay or forfeit as well as any additional action to be taken. In all cases, a report shall be sent bythe referee to the JCSC within 48 hours of the occurrence.
A. Referee Training

62 All referees must be certified under USSF procedures.
63 Youths must be 13 years old by the date of the first game of the next season to be eligible to be trained.

64 Referees certified as level 9 can only referee JCSL games at JCSL fields.
B. Referee Certification

65 All RYSL referees must be re-certified annually in a course offered by a USSF-certified Referee instructor or online. Each referee must pay his or her own certification fee.
For a referee to be able to referee JCSL games the following must be met:
66 They must attend at least 2 referee meetings per year. One must be a re-certification meeting, which can be attended anywhere in the USA. The other must be a JCSL meeting. They must fulfill all assignments by either refereeing those games, or finding qualified substitutes. Notifying the coaches that you will be absent does not satisfy the requirement.
C.. Referee Pay Rate - Dollars per Game per Referee

The following rates apply only to certified referees.
67. Referee pay rate is as follows: U8-\$10.00
U10 - Center \$15.00, U10 Line \$12.00 U12-U19: Center \$20.00, Line 15.00

## 18. Zero Tolerance Policy

To help prevent physical assault and verbal abuse in the leagues and clubs within the Jackson County Soccer League; the Association has adopted a ZERO TOLERANCE POLICY. This policyapplies to all coaches, players, parents, spectators and other supporters and referees effectiveimmediately. Abusive and obscene language, violent play/conduct, fighting and other behavior(including, but not limited to sarcasm, taunting, etc.) deemed detrimental to the game between the above mentioned groups will not be tolerated. The ultimate responsibility for the actions ofcoaches, players and spectators resides with the member clubs.
It is the responsibility of the coaches to provide referee support and spectator control, and it is the responsibility of the member clubs to provide instructions to their coaches on how they are expected to carry this out. This policy applies before, during and after the game at the soccer field and its immediate surrounding areas.

## A. Code of Conduct

The JCSL Code of Conduct is part of our By-Laws/Policies and Procedures and must be followed by everyone on the soccer fields. Everyone will act in accord with this code. The league officials will and should expect that everyone follow this code. Anyone not following these rules is subject to disciplinary actions by the Disciplinary Board, not limited to expulsion from club activities.

1. Make soccer participation for your child and others a positive experience.
2. Remember that a child is easily affected by outside influences.
3. Be kind to your child's coach and to the officials. Be kind to the opposing team parents and their coaches.
4. Applaud good plays by your team AND by members of the opposing team.
5. Parents should be cheerleaders. Allow the coach to coach, the referee to officiate, and most of all allow your child to play the game.
6. Between the exuberance of the winner and the disappointment of the loser, we have the referee. All of them follow the same creed to watch every movement of every player, and to call the game to the best of their ability. DO NOT openly question their judgment, and never their honesty. They are a symbol of fair play, integrity and sportsmanship.
7. Accept the results of each game, and encourage your child to: Be gracious in victory, and turn defeat to victory by working towards improvement. Set a good example of sportsmanship for the children.
8. ABUSIVE OR PROFANE LANGUAGE WILL NOT BE TOLERATED ON THE SOCCER GROUNDS OR TOWARD ANY PERSON IN ATTENDANCE.

## B. Parents \& Spectators

No parent or spectator shall persistently address the referee or assistant referees at any time.
This includes, but is not limited to:
Parents and spectators shall not dispute calls during or after the game.
Parents and spectators shall not make remarks to the referee(s) or advise the referee(s) to watch certain players or attend to rough play.
Parents and spectators shall never yell at the referee(s), including criticism, sarcasm, harassment,
intimidation or feedback of any kind before, during or after the game.
The only allowable exceptions to the above are:
Parents and spectators may respond to a referee who has initiated a conversation, until such time as the referee terminates the conversation.
Parents and spectators may point out an emergency or safety issues, such as a player apparently injured on the field or observed fighting.
Additionally, parents and spectators shall not make derogatory comments to players of either team.
C. Penalties (Parents \& Spectators)

In the opinion of the referee, depending on the severity of the offense, the referee may take any of the following actions:

1. The referee may issue a verbal warning to the coach of offending party's team.
2. The referee may stop the game and instruct the coaches to direct the parent / spectator to leave the field.
3. The referee may abandon the game if the parent/spectator does not leave the field.
4. Any person told to leave the field by the referee, must do so. In return, said person will be subject to discipline:
a. Person receiving discipline, will not be permitted on the soccer fields or any Soccer function for 1 (one) week from date of incident.
b. Before returning, said person must sign a misconduct form, stating they acknowledge their wrong doing.

## D. Players

The conduct of the players is governed by the Laws of the Game as stated by FIFA and USSF. The Laws themselves describe penalties associated with violating the Laws of the Game. Additional penalties for players who engage in misconduct may be established by the club and/or league but may in no case be less severe than penalties established by FIFA, USSF or JCSL.
E. Coaches, Assistant Coaches \& Bench Personnel

It is the responsibility of all coaches to maintain the highest standards of conduct for themselves, their players and supporters in all matches. Failure to do so undermines the referee's authority and the integrity of the game resulting in a hostile environment for players, the referee(s), coaches, assistant coaches, bench personnel and spectators. As role models for all of the participants and spectators, coaches participating in a JCSL sanctioned event are expected to be supportive of, and to acknowledge the effort, good play and sportsmanship on the part of ALL players from either team in a contest. By example, coaches, assistant coaches and bench personnel are expected to show that although they are competing in a game, they have respect for their opponent, referees and spectators at all times. The Ripley Youth Soccer League will not tolerate negative behavior exhibited either by demonstrative actions and gestures, or by ill-intentioned remarks, including those addressed toward the referees or members of an opposing team. Coaches exhibiting hostile, negative, sarcastic or otherwise ill-intended behavior toward referees, opposing players or coaches will be subject to sanction by the match official. Additional sanctions may be imposed by the club that the coach or assistant coach represents, the league that the match is being played under, or as allowed by Jzckson County Soccer League policies after a review of the match report. Coaches shall not interact
directly or indirectly with the coaches or players of the opposing team during the game in any manner that may be construed as negative, hostile or sarcastic either by way of demonstrative actions and gestures or by ill-intentioned remarks.

Coaches shall not offer dissent to any call made by the referee(s) at any time.
Coaches are not to address the Referee(s) during the game except to:
a. Respond to a referee who has initiated a conversation.
b. Point out emergency or safety issues.
c. Make substitutions.
d. Ask the referee, "What is the proper restart (i.e. direction and Indirect Free Kick or Direct Free Kick)?
e. Ask for the time remaining in the half.

Coaches are allowed to ask a referee after a game or during the halftime interval, in a polite and constructive way, to explain a law or foul, but not judgment calls made in the game.
a. Polite and friendly concern can be exchanged with the referee. If the polite tone of the conversation changes, the referee may abandon the exchange at any time.
b. Absolutely no sarcasm, harassment or intimidation is allowed.

NOTE: It is recommended that coaches or other team members do not engage in any conversation
with the match official once the match has concluded.
F. Penalties (Coaches, Assistant Coaches \& Bench Personnel)

In the opinion of the referee, depending on the severity of the offense, the referee may take any of the following actions:
a. The referee may issue a verbal warning to the offending coach, assistant coach or bench personnel.
b. The referee may eject the offending coach, assistant coach or bench personnel.

Once ejected, the individual will be required to leave the field immediately.
NOTE: Referees are instructed not to display any cards to bench personnel.
They are strictly reserved for players and substitutes.
c. The referee should abandon the game, if the coach, assistant coach or bench personnel do not leave the field or any immediate adjoining area after having been instructed to do so.
Additional penalties associated with the ejection of a coach, assistant coach or bench personnel may be assessed by the club or league which sanctioned the match in accordance with their documented policy. These penalties may be no less stringent than sanctions as may be imposed by JCSL following their review, if conducted, of the incident.
G. Discipline
a. Coach, Asst. Coach, Bench Personnel receiving discipline, will not be permitted on the Soccer fields or any soccer function for 1 (one) week from date of incident.
b. Before returning, they must sign a misconduct form, stating they acknowledge their wrong doing.
All cases of alleged abuse or assault of a referee shall be reported to the JCSL Board
within 48 hours of the match that engendered said behavior. JCSL will then conduct a verification of the complaint and subsequent actions as required by applicable sections of USSF/FIFA Policy in effect at the time of the incident. Although JCSL is continually bound by USSF/FIFA Policy and its various revisions, definition of referee abuse and referee assault found in USSF Policy 531-9 as of the creation date of this Zero Tolerance Policy is offered by way of information as follows:

## 1. Referee Abuse

(a) Referee abuse is a verbal statement or physical act not resulting in bodily contact which implies or threatens physical harm to a referee or the referee's property or equipment.
(b) Abuse includes, but is not limited to the following acts committed upon a referee: using foul or abusive language toward a referee that implies or threatens physical harm; spewing any beverage on a referee's physical property; or spitting at (but not on) the referee.

## 2. Referee Assault

(a) (i) Referee Assault is an intentional act of physical violence at or upon a referee.
(ii) For purposes of this Policy, "intentional act" shall mean an act intended to bring about a result which will invade the interests of another in a way that is socially unacceptable. Unintended consequences of the act are irrelevant.
(b) Assault includes, but is not limited to the following acts committed upon a referee: hitting, kicking, punching, choking, spitting on, grabbing or bodily running into a referee; head butting; the act of kicking or throwing any object at a referee that could inflict injury; damaging the referee's uniform or personal property, i.e. car, equipment, etc.

## 19. PARENTS

Parents/Guardians are expected to have players attend as many practices and games as possible.
Parents/Guardians are to provide positive reinforcement for all players. (This includes both their team and the competitors). All parents/guardians must read and understand Section 4, Sportsmanship and understand that they are subject to disciplinary actions by the Disciplinary Board, not limited to expulsion from club activities.

## 20. PETS

68 Pets are not to be on or around the soccer fields, during practices and/or games. Anyone choosing to not follow this rule, is responsible for any damages their pet does to others.

## 21. TOBACCO USE

69 Tobacco products, including vaping, is not permitted on or around the fields at Whiting Park. The health department has signs posted at the entrance to the fields. Signs are also posted around the soccer fields.
22. TOURNAMENT PLAY

70 Coaches are encouraged to participate in Tournaments.
71 It is not mandatory for a player to attend Tournaments that their team enters.
72 Costs for Tournaments will be covered by the parents/guardians of each player.

JCSL Disciplinary Board.
23. REGISTRATION FEE AND REFUNDS

73 Registration fee is $\$ 60$ per season.
74. NO refunds will be given.

## 24. REVISIONS OF RECREATIONAL GUIDELINES

These JCSL Recreational Soccer Guidelines are the general rules for recreational play. These guidelines may be modified at any time at the discretion of the RYSC Board Members. Approval of modification requires a majority vote of Board members present during any board meeting (regular or special) with a quorum present. Any changes to the Constitution, Bylaws, or Guidelines must be submitted to WVSA within 30 days of adoption. Revisions must conform to WVSA Constitution, bylaws, and policies and procedures and to all requirements of WVSA, USSF and or USYSA and USASA.

These POLICIES AND PROCEDURES ADOPTED of the JCSL shall become effective on the second (2) Day of May in the Year of TWO THOUSAND AND TWENTY THREE (2023).
